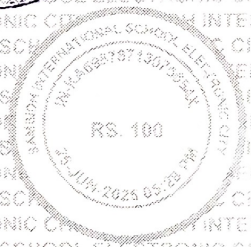
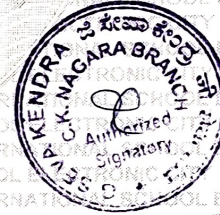

ಮೇಲಿನ ವಿಷಯಕ್ಕೆ ಸಂಬಂಧಿಸಿದಂತೆ, Samsidh International School, Electronic City, S.No.22/7 & 24/5, Gollahalli Main Road, Next to MJR Apartment, Neo town circle, Electronic city, Bangalore-560100 has requested in the letter of reference (5) to issue a building safety certificate for educational purposes to the school building here.

In the judgment given by the Supreme Court in Writ Petition (Civil) No. 484 (2004), the Executive Engineer, Public Works Department has been ordered to inspect the school/college buildings and issue a "Structurally Stable Certificate" and as per the directions of the House Rules in reference (1), structural evaluation of the existing buildings already constructed and issued a certificate as per the National Building Code norms, as per the Government Circular No. LoE 59 BED 2019, dated 07.05.2022 regarding the proposed building.



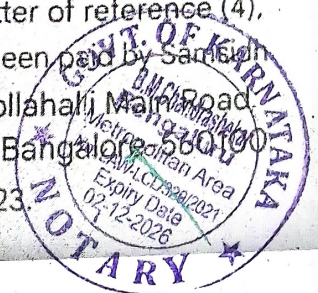

It has been 5 years since the construction of this building. Regarding the strength of the building, the institution has provided the following documents.

- K.Chandana, Civil Engineer, Dommasandra, Anekal Taluk, Bangalore-562125, Reg.No.BCCL/BL-3.6/E-0314/21-22 2 2 Structural Design Sufficiency 2, ಪ್ರಮಾಣ (Annexure-C).
- As the period is less than 5 years as per the Government circular, the building has ಸುಕ್ರೋಲಯಂತೆ ಕಟ್ಟಡವನ್ನು been constructed as per the design of Columns, Beams and Slab as per the test report of K.Chandana, Civil ಇಂಜಿನಿಯರ್ Engineer, ಪರೀಕ್ಷೆ Dommasandra, Anekal Taluk, Bangalore-562125, Reg.No.BCCL/BL-3.6/E-0314/21-22 of reference (3), NDT, IS ನಲ್ಲಿ ನಿಗದಿಪಡಿಸಿರುವ ಮಾನದಂಡದಂತೆ ಕಟ್ಟಡದ ಕಾರ್ಯಕ್ಷಮತೆ Code:456-2000, IS Code:4926-2003, IS Code:516-1959 and 8112-1989 for 43 grade, and the building is sound. - Regarding the Non-structural Elements (Infrastructural facilities) of the proposed building, a no-objection letter should be obtained from a testing team consisting of a Civil Engineer, Health Officer, Revenue Officer, Psychologist, Fire Officer, and officers of the local body, and a "Fire Safety Certificate" should be obtained from the Chief Fire Officer.


After verifying all the documents provided by the said institution, a no-objection letter has been issued stating that the school building is "Structurally Stable" subject to the condition of immediate repair of 5 Hair line Cracks.
