7. **Supervision:** The school is subject to inspection and supervision by the Education Department, and must submit required details and documents through SATS as instructed.

That, based on the above Recognition Order and continuing compliance by the School with the RTE Act, 2009, the Karnataka Education Act, 1983, and the conditions contained in the Order, it is declared that the said Recognition remains in force and shall be treated as valid for the Academic Year 2025-26 & 2026-27 (i.e., from 13-Nov-2025 to 31-May-2026 and 01-Jun-2026 to 13-Nov- 2026) unless withdrawn or modified by the competent authority.
